Inveneo Partner Program (ICIP/ICT) - Inveneo trains and partners with ICT professionals across Africa, Asia Pacific, the Middle East and the Caribbean through its Inveneo Partner Programs. Inveneo recruits, vets, trains, certifies and enters into long-term partnerships with small and medium sized IT entrepreneurs, called Inveneo Certified ICT Partners (ICIPS). We deliver a formal training process and certification process to empower these in-country ICT entrepreneurs with the tools, skills and ongoing support to implement sustainable computing and connectivity solutions for organizations operating in rural and underserved communities.

4b (Code:) (Expenses \$ 322,138 including grants of \$ 0) (Revenue \$ 684,396)

Inveneo's Broadband for Good program accelerates access to high quality broadband services in underserved regions. The connectivity is used to drive community and economic development through access to improved education and health services, better economic opportunity and faster relief. Inveneo is designing and demonstrating a framework and process for financially sustainable models for delivering Broadband using radically lower cost technologies and delivery systems by building capacity and ICT jobs for local ICT entrepreneurs and rural youth.

Through its Direct Services Program, Inveneo provides expert guidance, systems integration and project management for implementing sustainable ICT projects for non-governmental organizations and governments in developing countries so that these organizations can use ICT more effectively to deliver education, healthcare, economic development and relief programs.
